**The College is directed to abide by the following conditions:**

**I. Specific Conditions:**

1. Regular Faculty members to be recruited to all vacant teaching positions immediately.
2. College is advised to purchase 23 additional computers for B.Sc. Computer Science course immediately.

**II. General Conditions:**

1. The observations made by the Inspection Committee that have been agreed to be implemented as undertaken by the College in the Undertaking sent vide your letter 4<sup>th</sup> cited should be complied with. All Affiliation Conditions of Pondicherry University, with respect to admissions, faculty recruitment, fee collection from students, conduct of Exams, etc., should strictly be adhered to by the Colleges.
2. Colleges offering such courses which require approval of Statutory Body like AICTE/NCTE/MCI/INC/BCI/DCI, etc., should not conduct admissions until their clearance.
3. All Govt. of India schemes should be implemented and necessary students activities for Nation Building should be carried out.

4. The UGC directions in controlling Ragging in campuses, Drug abuse, Sexual Harassment shall be strictly adopted.
5. The University reserves the right to utilise all the information submitted by Colleges relating to faculty profiles, etc., for answering all RTI queries, legal requirements, CBI enquiries, etc.
6. The Governing Body meetings should be organized regularly. Compliances to different GOI organisations like ESI, PF, Gratuity, GST, Income Tax authorities should be made and a copy of audited annual accounts should be submitted to the University.
7. Insurance, Fire Service NOC, Groundwater user license and PPA permit should be renewed periodically.
8. The College should take pro-active measures for rain water harvesting and recharging ground level water as per the Minutes communicated vide letter dated 24.07.2018.
9. Surprise checks will be conducted to ensure whether all the compliances reported have been actually taken care of. In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.
10. The jurisdiction in respect of any dispute against Pondicherry University relating to affiliation, shall be at Madras High Court only.
11. The Provisional Affiliation shall be valid only for a period of one academic year i.e. 2021-22 subject to ratification by the AC/EC of the University.

8. At least 10 journals to be subscribed for each PG Course. Subscription to E-Journals should be made.
9. Subscription to the following databases should be made urgently:  
1. Prowess 2.Ebsco
10. 23 additional Computers should be provided for computer lab.
11. Subscription to the following software/ Databases need to be made:  
1. Microsoft 2.Simulation software 3.CMIE. 4. India Start.
12. Procurement of additional equipments for all Labs should be made.
13. General amenities like Transport, Auro Drinking Water, Women Rest Rooms, Canteen need to be provided.
14. Facilities for differently Abled students need to be created.
15. Budget allocation for Sports equipments to be made.
16. Rain Water Harvesting to be implemented.
17. NSS/NCC officer to be provided.
18. Biometric attendance for every department to be introduced.

19. College old building requires PWD Certificate for students safety.  
20. Fire safety Certificate needs to be submitted for the new building.

You are requested to rectify the above deficiencies and submit a compliance report along with supporting documents/proof. You are also required to submit an Undertaking on a non judicial Stamp paper, duly attested by a Notary Public for fulfilling the affiliation conditions prescribed by the University in the Annexure of this letter.


The Fees is required to be paid in the form of Demand Draft drawn in favour of the Finance Officer, Pondicherry University, Puducherry. Failure to pay the required funds **within 10 days from the date of receipt of this letter** would attract penalty as follows:

**Late fee:**

Upto 15 days - Rs. 50,000/-  
Upto 30 days - Rs.1,00,000/-  
Beyond 30 days - Rs.1,00,000/- + Rs.4,000/- per day for a period of one month till closure.

You may please note that continuation of provisional affiliation for the above said courses for the academic year 2021-22 would be considered only on rectification of the above shortcomings and submission of compliance report with supporting documents along with the required undertaking & payment of prescribed Affiliation / Inspection funds as mentioned above.

The College should not admit students for the above courses for the academic year 2021-22 without the approval of the University.
